

PRIVACY POLICY

This Privacy Policy (“Policy”) outlines the personal information that [CHENNAKESHAHA FURN INDUSTRIES](“we”, “us”, or “our”) gathers, how we use that personal information, and the options you have to access, correct, or delete such personal information. This Policy applies to the [DocuView Pro](“App” or “Service”).

If we modify this Policy, we will publish a revised version with an updated revision date. The privacy link on the footer of the App will then point to that new version.

A. COLLECTION OF PERSONAL DATA

If you refuse to provide your personal information, we may not be able to provide you with the full functionality of the App. Personal data that may be collected by us includes:

- the type, version, brand, language and operating system of device.
- the type and operator of network (such as Mac address).
- behavioral usage of the App.
- email address.
- device identifiers (such as IDFA, IDFV for Android, GAID for IOS).

B. HOW WE USE PERSONAL DATA

Our purposes for processing personal data:

- To enter into or fulfil agreements with you, including to deliver and manage our Services.
- To manage, develop and improve our Services.
- To detect, prevent, and investigate misconduct by our users.
- To address and resolve enquiries and complaints.
- Compliance with legal obligations in respect of relevant laws.

C. HOW WE SHARE PERSONAL DATA

We may share and/or disclose your personal data as follows:

- Disclosure within our group of entities.
- Disclosure to service providers or other third parties. We work with service providers and other third parties to manage or support our business operations.
- We may also share your personal data with third parties to: (i) respond to duly authorized information requests of police and governmental authorities; (ii) comply with law, regulation, subpoena, or court order; (iii) enforce/protect our rights and properties.

D. PERSONAL DATA OF MINORS

We do not knowingly collect personal data from minors without proper consent from a parent or legal guardian. If you believe that we may have collected personal data from a minor without the requisite consent, please let us know and we will investigate and promptly address the issue. For these purposes, we define a "minor" to mean an individual who is under the age of majority in the territory in which they are resident.

E. YOUR RIGHTS IN RELATION TO YOUR PERSONAL DATA

Depending on what data protection laws you are subject to, you may have the right to request to:

- Access or obtain copies of personal data we process about you.
- Rectify your personal data, if inaccurate or incomplete.
- Delete or anonymize your personal data, unless an exception applies. For instance, we may need to keep your personal data to comply with legal obligation.
- Restrict the processing of your personal data in certain circumstances.
- Object to processing of your personal data, in certain circumstances.
- Withdraw consent to the processing of your personal data.

the contents of those sites or resources, and accept no responsibility for them or for any loss or damage that may arise from your use of them.
