

TERMS OF USE

These Terms of Use ("Terms"), along with our Privacy Policy, govern your use of [CHENNAKESHAHA FURN INDUSTRIES]("we", "us", or "our")'s [DocuView Pro]("App" or "Service"). Please read the following carefully as it affects your legal rights.
